



## Voluntary Authorization For Release Of Information

The undersigned is currently either a driver applicant or an over-the-road driver with Schneider National, Inc., or one or more of its affiliated companies, or its parent company (“Schneider”) and has expressed an interest in possibly driving in a team arrangement for Schneider. In order to help the undersigned locate another team driver, Schneider has implemented a list of individuals who are likewise possibly interested in driving as a team driver and the undersigned would like for his or her Personal Data to be included on such list. In order for Schneider to add such information to this list and distribute it to other individuals, the undersigned agrees as follows:

1. Schneider may add my name, address, phone number and/or electronic mail address (“the Personal Data”) to a master list of individuals who are interested in selecting other Schneider driver applicants (or Schneider drivers), to drive with them as a team driver with Schneider.
2. Schneider may include my Personal Data on a web-accessible site that is available to other Schneider employees and may disclose my Personal Data to potentially interested Schneider driver/driver applicants who may be interested in team driving.
3. The posting or distribution of my Personal Data does not mean that I will be offered a job as a team driver with Schneider or that Schneider is responsible for locating another driver applicant or driver who is willing and able to drive as a team with me. I know that I must either contact such other individuals directly or that they will contact me, but in no event do I expect Schneider to contact any individuals on my behalf to arrange the team driver process. I do however, agree that Schneider may contact me to help arrange for me to become a team driver with Schneider through this process.
4. I further agree that I am solely responsible for researching the compatibility of any such individual who may contact me for a team arrangement and that the inclusion of such names on this list is not an endorsement or recommendation by Schneider of such individual.
5. This is a purely voluntary option and is being offered simply as a means to help me locate a team driver, if I should so chose. I am under no obligation to grant this authorization and I may revoke it at any time.
6. In order to revoke this authorization, I must give Schneider written notice of my revocation. This authorization shall be effective unless and until I give such written notice to Schneider at its Driver Recruiting department.
7. I release and hereby agree to defend and hold Schneider (their employees, officers, directors, agents and representatives, together with their successors and assigns) harmless against any claim, obligation, loss, judgment, damage or liability arising out of or related to any actions or inactions taken by Schneider in reliance upon the authorization and release granted herein.
